



PIM 2006-004 Uniform Selection

- The purpose of this PIM is to provide guidelines team uniform selection, clarifying the definition of teams in section 4:04 of the MVLA constitution.

Policy Interpretation:

4:05 UNIFORM STANDARDS

4:05:01 The Board shall from time to time designate a Primary Uniform in standard and alternate colors, a Secondary Uniform in standard and alternate colors (hereinafter, "Designated Uniforms"), artwork for the MVLA club logo and/or artwork for the MVLA letters on uniforms. The Board will upon petition of a majority of the teams then in good standing with the club designate new uniforms or artworks.

4:05:02 All teams must use a Designated Uniform for spring league play. A Primary Uniform is mandatory for all U11 and older teams playing during the fall season, at tournaments and at cups.. In the event of a change of a Designated Uniform a team may play two subsequent fall seasons in any previously appropriate Designated Uniform or longer with Board approval.

4:05:03 Failure to comply with this UNIFORM STANDARDS clause may result in disciplinary action by the Board, including but not limited to, declaration of a team as not in good standing with the club.

4:05:04 PRIMARY UNIFORM

4:05:04:01 The Board may declare one or more vendor's uniforms as a the Primary Uniform (in standard and alternate colors) or the Board may promulgate a functional specification for the Primary Uniform. In the event a vendor uniform is so designated it must meet the following requirements:

- a) There must be an MVLA Logo in accordance with the approved artwork on the left upper front of the jersey.
- b) There must be the letters "M V L A" in accordance with the approved artwork across the chest below the logo.
- c) The Standard Primary Uniform will be predominantly Navy Blue (Pantone 281, RGB 0,0,105).
- d) The Alternate Primary Uniform will be predominantly White (Pantone White, RGB 255,255,255).
- e) Royal Green (Pantone 368, RGB 0, 158, 15) is permitted as a trim color. No colors other than Navy Blue, Royal Green and White are permitted.



- f) Player numbers must be on the back and either in Navy Blue or White as appropriate.
- g) Player names on the back are not permitted .
- h) Player numbers on the left front leg of the shorts are not permitted .
- i) Team sponsor branding is not permitted without prior Board approval

4:05:04:02 Reasonable alternatives to the designated vendor's uniform(s) are permitted; however it is the responsibility of the team desiring an alternative to request and receive Board approval before fielding such a uniform in any sanctioned game

4:05:05 SECONDARY UNIFORM - The Secondary Uniform is a cotton or cotton/polyester blend T shirt and matching shorts meeting the following requirements

- a) The requirements of sub-sections of section 4:05:04:01 must be met.
- b) Only short sleeve and sleeveless are permitted, No long sleeve or tank top are permitted.
- c) The Standard Secondary Uniform will be Navy Blue(Pantone 281, RGB 0,0,105).
- d) The Alternate Secondary Uniform will be White (Pantone White, RGB 255,255,255).
- e) No trim colors. No colors other than Navy Blue, Royal Green and White are permitted.
